

ORDER:

1. The PCI, New Delhi has accorded approval to Sri Padmavathi Institute of Pharmaceutical Education & Research, Vaishnavi Nagar, Tiruchanoor, Tirupati Rural Mandal, Tirupati for the academic year 2025-26 vide ref (1) read above. The University has constituted a Fact Finding Committee to verify the staff and infrastructure facilities of the college to consider for grant of Temporary affiliation for the academic year 2025-26 vide Procs. (2) read above. The Fact Finding Committee has visited the college and submitted its report to the University vide (3) read above. The University has constituted a Standing Committee for Affiliation to verify the reports which were submitted by the Fact Finding Committee. The Standing Committee for Affiliation of the University has verified the report which was submitted by the Fact Finding Committee and made recommendations for granting Temporary Affiliation for the academic year 2025-26 vide (4) read above. The University has communicated the college to APEAPCET-2025 admissions counseling subject to clearance from the Govt. of A.P vide (5) read above.
2. Under the circumstances as stated above, the Vice-Chancellor is pleased to Grant **Temporary Affiliation** to “Sri Padmavathi Institute of Pharmaceutical Education & Research, Vaishnavi Nagar, Tiruchanoor, Tirupati Rural Mandal, Tirupati” sponsored by “Lords Auxiliary for Rural Development, Mohan Nagar, S.N.Puram, Tirupati” to offer the following courses with the intake shown against each for the Academic Year 2025-2026 as detailed below and subjected to rectify the following deficiencies within six months.
 1. The college authorities have informed that facilities such as library, examination session, seminar hall, canteen, few laboratories, equipments will be shared with the pre-existing college i.e., Sri Padmavathi School of pharmacy located in the same campus.
 2. There is no wall of compound with the other pharmacy college located in the same campus, so the facilities like parking road, sports and indoor facilities will be shared with Sri Padmavathi School of Pharmacy located in the same campus.
 3. Internet facility was subscribed for one month and the bill date is 18-06-2025 to 17-07-2025 with prepaid bill.
 4. the toilet rooms (boys and girls) have not been observed in the college building, it was away from the college building.

5. There is no document indicating land allocation from the society in the name of this college.
6. The building premises and other facilities shown to the committee during virtual FFC visit pertains to the infrastructure and equipment available in the existing college located in the same premises.
7. The location and extent of land as claimed by the college authorities in Sy.No.449/1,2,3 has not been clearly mentioned in the land records (land survey plan) but all approvals like structural stability certificate, sanitary certificate, fire safety certificate etc and documents pertaining to this college have been sanctioned in the above survey numbers under the name of the society instead of name of the college.
8. Audit statement, land conversion, land use certificate, bank account etc are in the name of society instead of name of the college.
